Hard economic times require leadership with expertise and skills in drafting, passing, and enforcing policies and law that help people stay solvent. My skillset uniquely fits this type of leadership need. Twenty years of litigation and policy experience in helping working families, seniors, and marginalized members of our community have forged me into a person adept at finding solutions to tough problems. This is the type of Mayor the City of Lemon Grove needs—one with experience in protecting and aiding people in difficult financial times.

I have spent more than a decade serving my community at the Legal Aid Society of San Diego providing free legal services to low-income people. I now lead the Housing Rights Project at the University of San Diego Law School, where we provide free legal services to people facing eviction and foreclosure. I designed and launched two debt defense clinics and created San Diego's bankruptcy self-help center and clinic. My work has focused on helping others achieve housing and financial stability, avoid financial fraud, and to ensure families do not go hungry.

A critical part of my advocacy and service to the community has been to fight for policies that promote housing stability and financial security. I have battled against legislation that would harm the low-income people, socially disadvantaged communities, and our senior citizens.

I have collaborated with the White House, the Consumer Financial Protection Bureau, the California Department of Financial Protection and Innovation, the U.S. Department of Energy, and the Federal Trade commission on consumer and housing issues. I am a frequent speaker at the National Consumer Law Center, American Bar Association, and National Legal Aid and Defender Association conferences on broad range of consumer protection issues. I have also been interviewed by a range of media, including HBO's John Oliver Show, Bloomberg, Vice, L.A. Times, The Guardian, Univision, and Telemundo. I have been a requested panelist by the Consumer Financial Protection Bureau and the Federal Trade Commission.

### 1. What are your top priorities if elected to office?

- Housing and homelessness. Addressing housing and homelessness is my top priority. Lemon Grove historically was a place you could afford to buy your first home. That's one of the reasons we chose to raise our family here. We could afford a home on a Legal Aid salary. Housing prices have skyrocketed, but I want Lemon Grove to still be the place you can afford to buy your first home. For our unhoused, I working on building partnerships with the State, the County, and other cities in the region to bring shelter to East County. We are also working on as many solutions for homelessness and the problems that create it..
- Infrastructure. Lemon Grove financially struggled for many years and has a large amount of major deferred maintenance issues. The streets are in deep need of repair. Moreover, to promote a cleaner, healthier community, the City needs sidewalks and better lighting to encourage walkability and biking.

• Financial Stability and Business Development. After surveying our downtown businesses, the first and most urgent area of concern for the owners was the unhoused population. So, my first and third priorities overlap. As people obtain shelter, we can focus on attracting businesses to fill the vacant storefronts and bring in much needed tax revenue to the City.

# 2. What experience do you have improving the business environment in East County San Diego and how do you propose increasing economic development?

One of my key priorities when I ran for City Council was improving our business environment. I asked for and received assignments on the Council to work with the East County Economic Development Council and the East Area Chamber of Commerce Government Affairs Committee. I have regularly attended meetings and taken the tips, tricks, and solutions proffered in those meetings back to our community.

For example, James Sly spoke about small business assistance available through the East County Economic Development Council. When a local woman trying to start a business ran into confusing policies and red tape reached out to me, I referred her to the ECEDC and gave her contact information. Long story short, with a little bit of help and guidance, she has opened up her shop and is busy selling allergen-free donuts to the delight of many.

I am also on the Government Affairs committee of California Jobs First—a program designed to channel funding to help disinvested communities, like Lemon Grove. The initial catalyst grant for this program is \$14 million. Even a small slice of funding like this can aid in transforming our downtown and local businesses.

I am also constantly building relationships and networking to help connect our business with resources available to them.
